Registration Open for the NAESCO 9th Annual Federal Energy Efficiency Market Workshop in Washington DC

The National Association of Energy Service Companies (NAESCO) is pleased to announce that registration is now open for its 9th Annual Federal Energy Efficiency Market Workshop to be held in Washington, DC on March 18, 2014. The workshop is entitled "Meeting Enhanced Energy Consumption Reduction and Performance Objectives at Federal Facilities through Strategic Use of ESPCs and UESCs". As it has in the past, the workshop is expected to attract federal facility, energy program, and contracting managers as well as ESCOs, energy efficiency vendors, and financial institutions all of whom continue to play a key role in generating energy efficiency investment at federal facilities. Since 1998, 300 U.S. Department of Energy's energy savings performance contracts (ESPC) projects have been awarded and more than \$3.08 billion invested in Federal energy efficiency and renewable energy improvements. The results add up to approximately 371 trillion Btu in life cycle energy savings and \$7.6 billion in cumulative energy cost savings for the Federal Government.

Terry E. Singer, Executive Director of NAESCO said "Attendance at the Federal Energy Efficiency Workshop has been at capacity every year, evidence of strong, continued interest in pursuing energy efficiency savings in federal facilities on the part of the federal government policy and program managers as well as the ESCO industry." She went on to say "Presented by a diverse and talented roster of speakers, the program's focus on overcoming remaining ESPC bottlenecks and maneuvering effectively in a changing political and economic environment is particularly timely for leaders in both the public and private sectors who are working on reducing energy consumption at Federal facilities."
